**MINUTES OF THE MEETING OF THE LOCAL GOVERNMENT
EMPLOYEE-MANAGEMENT RELATIONS BOARD
January 19 and 20, 2010**

The Board meeting was called to order by Chairman Curran at 8:30, January 19, 2010.

Item #2

With minor changes, the Board approved the minutes from the board meetings held on November 17, 18, and 19, 2009 and December 10, 2009.

Item #3

Case No. A1-045949, Clark County Education Association vs. Clark County School District. The parties submitted a stipulation to dismiss prior to the hearing. A motion was made to **approve the stipulation to dismiss and it was passed unanimously.**

Item #4

A. Case No. A1-045900, Mathew C. Burke vs. Clark County, deliberation and decision on language for the notice the County shall post regarding its prohibited conduct in this matter on all bulletin boards for communications with all County Personnel, per EMRB Order dated April 3, 2008, Item number 654A. **The Board approved the language of the order and**

directed the commissioner to insure that the order would be posted by Clark County on all bulletin boards.

B. Case No. A1-045927, Nye County Law Enforcement Association vs. County of Nye; and Nye County Sheriff's Office. Deliberation and decision on Motion to Reconsider, Reopen, and/or set aside order. **The Board denied the motion to reconsider and the original order of dismissal stands.**

C. Case No. A1-045929, Timothy Frabbiele vs. The city of North Las Vegas, North Las Vegas Police Department; North Las Vegas Police Officers Association. Deliberation and decision on post hearing blind briefs and on Hearing conducted. **The Board granted the Complainant's motion to correct the record and denied the motion to Strike portions of the Complainant's post hearing statement. The Board also found that the Frabbiele's Complaint exceeded the six-month statute of limitations of NRS 288.110(4), and ordered that this matter be dismissed with prejudice.**

D. Case No. A1-045939, Police Officers Association of the Clark County School District/COPS N-CWA, Local 9111 vs. Clark County School District. Review, and approve order. **The Board approved the order.**

E. Case No. A1-045944, Police Officers Association of Clark County School District vs. Clark County School District. Deliberation and decision on post hearing briefs and Hearing Conducted. **This case was tabled.**

F. Case No. A1-045946, General Sales Drivers, Delivery Drivers and Helpers, Teamsters Local Union No. 14 Affiliated with International Brotherhood of Teamsters, AFL-CIO vs. Las Vegas-Clark County Library District. Deliberation and decision regarding progress of case, including but not limited to, dismissal of, or the hearing of, the Complaint. **This case was tabled until the February meeting.**

G. Case No. A1-045950, Kisane Harper vs. City of Las Vegas Fire and Rescue. Deliberation and decision regarding Stipulation received January 11, 2010. **The Board approved the stipulation to extend the filing of the pre-hearing statements to January 29, 2010.**

H. Case No. A1-045951, Darlene Rosenberg vs. The City of North Las Vegas. Review Status Report and deliberation and decision regarding progress of case, including but not limited to, dismissal of, or the hearing of, the Complaint. **This case was tabled with a status report due 12/01/10.**

I. Case No. A1-045953, Juvenile Justice Supervisors and Assistant Managers Association, Inc. vs. Clark County. Deliberation and decision regarding progress of case, including but not limited to, dismissal of, or the hearing of, the Complaint. **The Board ordered**

a hearing.

J. Case No. A1-045955, Laurie Bisch vs. The Las Vegas Metropolitan Police Department and Las Vegas Police Protective Association. Deliberation and decision regarding progress of case, including but not limited to, dismissal of, or the hearing of, the Complaint. **The Board approved the stipulation to extend the time for the pre-hearing statements.**

K. Case No. A1-045957, Antonio Balasquide vs. Las Vegas Valley Water District. Deliberation and decision on Stipulation to Dismiss. **The Board approved the stipulation to dismiss this case. Vice-chairman Wilkerson recused himself from this case.**

L. Case No. A1-045958, Gisela Montecerin vs. Clark County School District. Deliberation and decision on motion to dismiss. **The Board denied the motion to dismiss.**

M. Case No. A1-045959, Stacey D. Madden vs. Regional Transportation Commission of Southern Nevada (RTC), Jacob Snow, General Manager; Jerry Keating, Assistant General Manager; Tammara Williams, Manager of Human Resources; Kenny Rodriguez, Manager of Customer Service; and Cassandra Campbell, Supervisor of Customer Service. Review, discussion, and acceptance of draft on motion to dismiss prohibited practices complaint. **This case was tabled.**

N. Case No. A1-045960, Police Officers Association of the Clark County School District vs. Clark County School District. Review Progress Report and deliberation and decision regarding progress of case, including but not limited to, dismissal of, or the hearing of, the Complaint. **The Board approved the progress report and is requiring another status report by 04/01/10.**
